(2.0) In case of deviation/falling of testing /quality of materials or unacceptable quality work, consultant shall have suggested corrective action also.

(3.0) Consultant Laboratory holder shall have valid Registration as Approved Laboratory and attach Copy of Registration Certificate NABL & ISO Certificate and GST registration, PAN Card, Professional Tax Registration with Tender .

(4.0) Consultants Laboratory holder should have a Laboratory within in Rajkot and experienced technical staff and IS Library.

(5.0) Consultants Laboratory should have to submit the List of Laboratory equipment's for **Non Destructive** testing with necessary documents and Valid Calibration Certificate, Experience of **Non Destructive test & Bar detector for steel reinforcement in concrete in Govt. organisation.**
